# NOTICE OF INTENT LIQUOR LICENCE APPLICATION OPPORTUNITY FOR INPUT

The City of Campbell River has been requested to provide the *Provincial Liquor and Cannabis Regulation Branch* with a resolution in support of the transfer of a Liquor Primary Licence from 1140 Ironwood Road (Voodoo Lounge) to 1620 Island Highway. The applicant, Salvatore Guzzo, is applying to transfer their existing Liquor Primary Licence.

#### The proposal includes:

• Transferring the Liquor Primary Licence from 1140 Ironwood Road (Voodoo Lounge) to 1620 Island Highway. The proposed hours for the Liquor Primary Licence are Monday to Sunday from 12 p.m. to 2 a.m. The applicant is proposing to utilize the Liquor Primary Licence to operate a live music night club, karaoke and comedy venue.
