DETAILS: The purpose of this Official Community Plan Amendment Bylaw is to include Great Blue Herons in the Bald Eagle Development Permit Area and improve the guidelines overall.

LEGAL DESCRIPTION: Various locations across the City. The Development Permit Area applies to lands:

- Within 60 metres of a Bald Eagle nest tree in all locations of the City
- Within 60 metres of a Great Blue Heron nest tree within the City's urban containment boundary or within 200m of a Great Blue Heron nest tree within the Comprehensive Development Area (which is land outside of the City's urban containment boundary but within City limits)

LEGAL DESCRIPTION: Various locations across the City. The Development Permit Area applies to lands:

- Within 20 metres of a slope that is both at least 30% grade and 10 metres high from the crest to the toe.
