## **COMMUNITY UPDATES**

### **Repairs for Lift Station #4**

Council directed staff to proceed with slope stability repairs for Lift Station #4, as recommended in the November 10, 2022 report from the Utilities Depart. The 2022-2031 Financial Plan was amended to reflect project funding in the amount of \$656,795 from the Sewer Reserve.

## **DEVELOPMENT UPDATES**

## 640 Willowcrest Road

Council gave first and second reading to a Zoning Bylaw Amendment to allow a future two-lot subdivision at 640 Willowcrest Road. The minimum lot size requirement was reduced from 450m<sup>2</sup> to 430m<sup>2</sup>, and the public hearing was waived.

## 2702 Island Highway South

Council approved Major Development Permit Application P2100078 for a six-storey, 80-unit rental apartment building with a variance to reduce the required parking spaces from 120 to 97 at 2702 Island Highway South.

# **1001 Island Highway - BC Ferries Terminal**

Council approved Major Development Permit Application P2200080 to update the BC Ferries Campbell River Terminal with a variance to reduce the front yard setback from 4.5m to 0.0m at 1001 Island Highway.

# 2337, 2341 and 2365 Quinsam Road

Council adopted Zoning Amendment Bylaw No. 3837, 2021, which rezones 2337, 2341 and 2365 Quinsam Road to Residential One A (R-1A), Residential Two (R-2) Zone, Residential Multiple Three (RM-3) Zone, and Comprehensive Development (CD) Zone.
