

# Freedom of Information and Protection of Privacy

Bylaw No. 3593, 2015

ADOPTED October 19, 2015

### PURPOSE

This bylaw is for the Administration of the Freedom of Information and Protection of Privacy Act.

The Council of the City of Campbell River enacts as follows:

#### PART 1: Title

1.0 This bylaw may be cited for all purposes as Freedom of Information and Protection of Privacy Bylaw, No. 3593, 2015

#### PART 2: Definitions

- 2.0 In this bylaw unless the context otherwise requires:
  - ACT means the Freedom of Information and Protection of Privacy Act, R.S.B.C. 1996 Chapter 165, as amended from time to time.
- **2.1** The definitions contained in Schedule 1 of the ACT, shall apply to this bylaw except where the context requires otherwise.

#### PART 3: Administration

- **3.0** The City Clerk is designated as the Head for the purpose of the ACT.
- **3.1** The Deputy City Clerk is designated as the Information and Privacy Coordinator for the purposes of the ACT, and is authorized to perform the duties and functions of the Head.

#### PART 4: Fees

**4.0** The Schedule of Maximum Fees as established by British Columbia Regulation 323/93, as amended from time to time, shall be the maximum fees charged by the City as permitted under the **ACT**.


#### PART 5: Repeal

**5.0** Freedom of Information and Protection of Privacy Bylaw No. 2882, 2001 is repealed.
