The City of Campbell River, Wei Wai Kum, We Wai Kai and Homalco Nations invite youth artists from each community to submit works on the theme PARTNERSHIP for consideration for inclusion and display in the jointly developed document entitled "Governance and Planning Partnership Strategy". Using the theme of PARTNERSHIP, the City of Campbell River together with the Wei Wai Kum, We Wai Kai and Homalco Nations are developing a "Partnership and Governance Strategy" which outlines a new approach for working together. The process has increased understanding of the rich cultural diversity in our community and the uniqueness. It has reinforced the need for the City and local First Nations to work together in partnership for the long term health and sustainability of the region.

Preference will be given to works that respond in some way to the theme of PARTNERSHIP. Individual interpretations or variations on the theme are encouraged. Youth Artists are asked to submit 2-dimensional (e.g. drawing, painting, collage, photography, etc.) or digital works.
