### PUBLIC ART COMMITTEE REQUEST FOR APPLICATIONS

The City of Campbell River is inviting interested members of the Public to apply for appointment to the City's Public Art Sub-Committee for the following terms:

- one member for 1 year,
- two members for 2 years, and
- three members for three years.

The Public Art Sub-Committee (PAS) will advise the Community Services, Recreation and Culture Commission on the following:

- effective implementation of the Public Art Policy
- public art planning
- allocation of Municipal funds for public art projects
- selection and placement of all public art works projects driven by public development
- development of a public art selection process, program and collection
- establish a public art program for the City and develop and maintain an inventory of public art

The Public Art Sub-Committee will require a diverse collection of individuals in order to reflect the diversity of community interests and will include:

- 2 Artists (recognized as Artists by their peers and active in the community)
- 4 Members that can represent the following: Arts, Culture, Recreation, Business, Heritage, People with disabilities, First Nations, Education, Community Advocate and/or Youth

We're making more room for you!

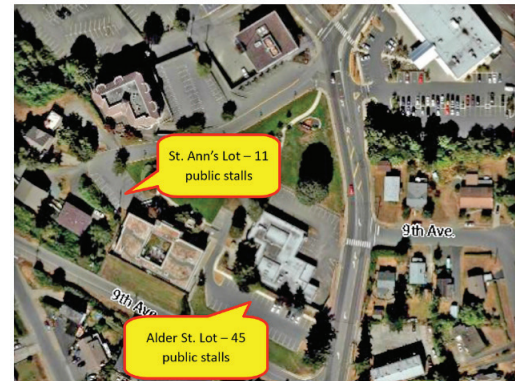
From June 22 to July 2 (inclusive)

Avoid the lineups! Mail your post-dated cheque or place it in the drop box at the front door to City Hall. Or make a payment online via your financial institution or use telephone banking. For more information, see the Frequently Asked Questions document posted online at [www.campbellriver.ca](http://www.campbellriver.ca). If you are interested in monthly pre-authorized withdrawals for payment of next year's taxes, look for the application form included with this year's tax notice mail out. Remember to claim your Home Owner Grant by July 2, 2015 to avoid a late penalty!
