NOTICE OF DISPOSITION OF PROPERTY

Pursuant to Section 24 and 26 of the Community Charter

TAKE NOTICE that the City of Campbell River (the "City") intends to dispose of the fee simple interest in the lands legally described as follows:

1) 440 Evergreen Road

Lot 1, District Lot 72, Sayward District, Plan EPP47377

The land, approximately 0.290 ha in size, is to be donated to the Campbell River Hospice Society for the purpose of constructing the Campbell River Hospice Facility. The consideration to be received by the City for the disposition is \$1.00.

The City also intends to dispose of the lands legally described as follows:

1) 3000 Spit Road

Lot A, Sayward Land District, Plan VIP72912, Lease Lot T of PL VIP82167

17-year extension to lease commencing on April 1, 2014 and terminating on March 31, 2031, to the Tyee Club of British Columbia for the Club's boat launch.

2) 655 Island Highway

Unsurveyed Crown foreshore or land covered by water being part of the bed of Discovery Passage, Sayward District, containing 0.32 hectares.

25-year Licence of Occupation Agreement to Ocean Networks Canada Society to provide access to the Discovery Pier for the purpose of installing equipment needed for the Smart Oceans BC program commencing on June 1, 2015 and terminating on May 31, 2040.

4) 1909 Lawson Grove

Lot 10. District Lot 210. Comox Land District. Plan 17188

5-year Licence of Use Agreement commencing on January 1, 2016 and terminating on December 31, 2020, to the Discovery Coast Greenways Land Trust for a community garden.

Please note that the City will remain the registered, fee-simple owner of the lands above.



Emergencies Can Happen Any Time, Anywhere and Without Warning

In the interest of public safety the City is installing generators at two Emergency Reception Centres: the Sportsplex and the Campbell River Community Centre. To carry out this emergency preparedness work, power will be disconnected. As a result, the Sportsplex will be closed to the public for four days, and the Campbell River Community Centre will be closed for one day.

During the Sportsplex closure, the public can register for recreation programs or make inquires by calling the Campbell River Community Centre at 250-286-1161.

During the Community Centre closure,the public can register for recreation programs or make inquires by calling the Sportsplex at 250-923-7911

To thank our customers for their cooperation and patience during the closures, fitness pass holders, who have a pass that is one-month or longer and is valid on December 21, will automatically receive a one-week pass extension.

FORESTRY TASK FORCE Request for Applications

The City of Campbell River is inviting interested members of the public to apply to serve on the City's Forestry Task Force.

The City is looking for seven (7) members who have experience and expertise in the coastal forest industry and community forests.

The purpose of the Forestry Task Force is to build on the work of the previous Future of Forestry Task Force and:

- in cooperation and consultation with the Forest Industry Governments, First Nations, Organizations and the public to provide City Council with recommendations, advice and guidance on relevant forest issues and initiatives to enhance the sustainability of the forest sector for the benefit of the City of Campbell River
- to enhance and retain existing business and attract new forest investment capital creating jobs and economic growth for Campbell River.
- to secure a community forest license for the City of Campbell River that will generate revenue, create employment, protect our watershed and wildlife habitat, enhance tourism and recreation, provide job training, research and education, and promote non-timber forest resource business opportunities.

Appointments to the task force will be for a maximum of 24 months.
