PUBLIC NOTICE FOR AMENDMENTS TO COUNCIL PROCEDURE BYLAW NO. 3277, 2007

Campbell River City Council will consider adoption of Council Procedure Amendment Bylaw No. 3614, 2016 at its Sept 6th meeting.

The proposed bylaw amendments will:

- Limit delegations to a maximum of 5 minutes;
- Require that delegations complete an application that would be placed on Council's agenda for information;
- Allow development applicants to address Council only if staff report includes a negative recommendation;
- Schedule delegations at the beginning of the meeting for up to a maximum of 30 minutes. All remaining delegations would present at the end of the meeting, except those delegations presenting on an issue that is on the agenda to be considered by Council;
- Establish a general rule of making a decision on a delegation's request at the next Council meeting;
- Only permit late delegations in exceptional circumstances;
- Create three new sections to the agenda entitled *Late Items*, *Information Reports* and *Council Liaison Reports*;
- Confirm that Council meetings generally occur every other Monday;
- Move the deadline for agenda submissions from Wednesday at 3 p.m. to Tuesday at 3 p.m.;
- Require that a Notice of Motion be read out at the meeting prior to the meeting where it will be considered;
- Update the Procedure Bylaw's section on "reconsideration" to provide better clarity on the process to reconsider decisions;
- Change the order of business on Council agendas so that Council debates priority issues first, allowing sufficient time to devote to its strategic priorities; and
- Based on best practices, incorporate a number of minor amendments that will: clarify definitions; include start time for public portion of the meeting; reschedule meetings that fall on a statutory holiday; replace "corporate officer" with "City Clerk"; replace "presiding member" with "chairperson"; remove redundant wording; amend wording to reflect that agendas are now distributed electronically.
