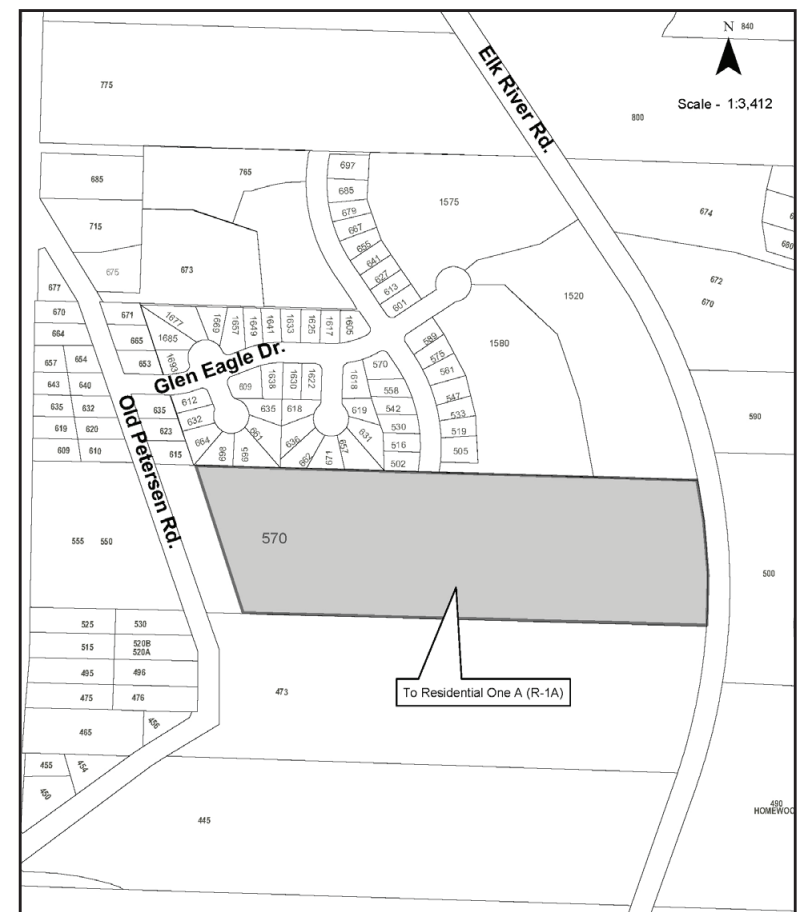
Where can I view a copy of the bylaw?
