#### IT'S BACK TO SCHOOL

A Public Hearing will be held in the Council Chambers of City Hall located at 301 St. Ann's Road in Campbell River, B.C. at 6:30 p.m. on September 11, 2017 to provide an opportunity for public input on Bylaw No. 3673, 2017.

What is the purpose of Zoning Amendment Bylaw No. 3673, 2017? Campbell River Head Injury Society is proposing to redevelop 531 9th Avenue for the purposes of a 27 unit apartment building to be designated as affordable housing. The applicant is seeking to rezone from Residential Multiple Three (RM-3) to Residential Multiple Four (RM-4) to allow for a higher density.


