

CAMPBELL RIVERREVISED WATER RESTRICTIONS PILOT PROJECT

The City of Campbell River is trying out revised water restrictions this summer – see below for a summary of changes.

STAGE 1 🄅

- ▲ Water lawns, gardens/trees/shrubs with sprinkler or irrigation system (3 days/week)
 - 4 a.m. to 8 a.m. and 7 p.m. to 10 p.m.
 - Even addresses: Mon/Wed/Sat Odd addresses: Tues/Thurs/Sun
- Water by hand with automatic spring load, micro-irrigation or drip-irrigation at any time (excluding lawns)
- All other activities allowed

CHANGED FROM:

Slightly-revised a.m. watering window (5 a.m. to 9 a.m.)

STAGE 2 🌣 🄅

- Water lawns, gardens/trees/shrubs with sprinkler or irrigation system (2 days/week)
 4 a.m. to 8 a.m. and 7 p.m. to 10 p.m.
 Even addresses: Mon/Sat Odd addresses: Thurs/Sun
- ♦ Water by hand with automatic spring load, micro-irrigation or drip-irrigation at any time (excluding lawns)
- ♦ Water new grass sod within 21 days of planting, or seed within 45 days of planting, with permit new watering permits available
- Manual washing of windows, vehicles allowed with automatic shut-off, along with other washing of exterior surfaces
- Filling of fountains and decorative features with automatic shut-off

CHANGED FROM:

- a.m. watering window only, 1 day/week
- No new watering permits for new grass sod or seeds
- No washing of windows allowed
- Car washing only allowed at commercial car wash/ dealerships
- No filling of fountains/features

STAGE 3 🌣 🌣 🌣

- ♦ Water lawns, gardens/trees/shrubs with sprinkler or irrigation system: (1 day/week)
 - 4 a.m. to 8 a.m. and 7 p.m. to 10 p.m. Even addresses: Monday Odd addresses: Thursday
- Water by hand with automatic spring load, micro-irrigation or drip-irrigation at any time (excluding lawns)
- No watering of new grass (sod or seed)
- ♦ No exterior window, house, driveway or outdoor surfaces washing

CHANGED FROM:

- No watering of lawns, gardens, trees, shrubs allowed with sprinkler or irrigation systems
- No watering of new grass
- No exterior washing
- Car washing only allowed at commercial car wash/ dealerships
- No filling of fountains/features

STAGE 4 🌣 🔅 🔅

- ▲ No watering allowed by sprinkler, irrigation system, or by hand
- ♦ No watering of new grass (sod or seed)
- No washing of windows, vehicles or exterior surfaces
- ♦ No filling of fountains or decorative features

PREVIOUSLY:

These restrictions were previously considered "Stage 3" of water restrictions
