

YOU ASKED: How to bag yard waste

Please use only paper bags or robust lidded containers, clearly labeled Yard Waste, for curbside yard waste collection.



Many clear lawn and garden bags are advertised as biodegradable, but they do not break down fast enough and end up contaminating the soil produced from Campbell River's yard waste. To keep the end product in good condition only unlined compostable paper bags will now be accepted with yard waste.

Plastic bags – even the ones considered biodegradable – will no longer be accepted at the curb or the Willis Road yard waste drop-off centre.

GENERAL VOTING DAY will be on Saturday, October 20, 2018 between the hours of 8 a.m. and 8 p.m. to qualified electors of the City of Campbell River at the following locations:

Campbell River Community Centre.....	401-11th Avenue
Sportsplex.....	1800 South Alder Street

ADVANCE VOTING OPPORTUNITIES will be held on Wednesday, October 10, 2018 and Wednesday, October 17, 2018 between the hours of 8 a.m. and 8 p.m. at the Campbell River Community Centre, 401-11th Avenue.

SPECIAL VOTING OPPORTUNITIES will be held at the Campbell River & District General Hospital, 375 2nd Avenue Thursday, October 18, 2018 between the hours of 9:30 a.m. and 11:30 a.m. (for patients who are duly qualified electors of the City of Campbell River)

MAIL IN BALLOT: the following electors are permitted to register to vote by mail and to vote by mail ballot:

- Those persons who have a physical disability, illness or injury that affects their ability to vote at another voting opportunity;
- Persons who expect to be absent from the jurisdiction on general voting day and at the times of all advance voting opportunities.

Information and an application form on how to apply for a mail in ballot package are available on the City's website at www.campbellriver.ca or by calling the Chief Election Officer before the close of voting at 8 p.m. on October 20, 2018. It is your responsibility to post the ballot in sufficient time for delivery to the Legislative Services Department at City Hall by the close of business at 4:30 p.m. on Friday, October 19, 2018, or arrange for the ballot to be hand delivered to the Presiding Election Official at the Campbell River Community Centre voting place, between 8 a.m. and 8 p.m. Saturday, October 20, 2018.

VOTER REGISTRATION: If you are not on the List of Electors (Voters' List), you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

Resident Electors must:

- be 18 years of age or older on voting day;
- be a Canadian Citizen;
- be a resident of BC for at least six months immediately preceding voting day (since April 19, 2018).
- be a Resident of OR registered owner of real property in the City of Campbell River for at least 30 days immediately preceding voting day (since September 19, 2018), and
- not be disqualified by any enactment from voting in an election or be otherwise disqualified by law.

Non Resident Electors must:

- be 18 years of age or older on voting day;
- be a Canadian Citizen;
- not be entitled to register as a Resident Elector of the City of Campbell River;
- have been a resident of BC for at least six months immediately preceding election day (Since April 19, 2018);
- have been a registered owner of real property in the City of Campbell River at least 30 days immediately preceding election day (since September 19, 2018); and
- not be disqualified by any enactment from voting in an election or be otherwise disqualified by law.
- If there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non resident property elector.

IDENTIFICATION ELECTORS who are not on the List of Residents (Voters' List) will be required to provide two pieces of identification confirming your identity and place of residence (one of which must contain your signature); or two pieces of identification confirming your identity (one of which must contain your signature) and you will be required to make a solemn declaration as to your place of residence.

Acceptable identification includes BC Drivers Licence, BC Identification Card, Social Insurance Card, Hospital Card, Passport, BC Care Card, (please note the combined drivers licence and care card are one piece of identification), Credit Card, Debit Card, Vehicle Insurance, Birth Certificate, Citizenship Card, tax notice or utility bill such as hydro, telephone, cable, showing residential address. Picture identification is not necessary.

NON RESIDENT PROPERTY ELECTORS will be required to fill out an application for registration by providing proof of ownership of the property (title or current title sheet); two pieces of identification confirming your identity (one of which must contain your signature); and a non resident property elector consent form of a majority of the registered owners, if there is more than one owner.

Non Resident Property Electors are encouraged to fill out the application and produce the required documentation at Campbell River City Hall, 301 St. Ann's Road between the hours of 8:30 a.m. and 4:30 p.m. prior to 4:30 p.m. on Friday, October 19, 2018.
