PARCEL TAX REVIEW PANEL FOR WATER, SEWER, STORM WATER AND PARKS PARCEL TAX ASSESSMENT

A Parcel Tax Review Panel will hear complaints regarding 2018 water, sewer, storm water and parks tax rolls.

When: 10:30 a.m. Tuesday, May 8

Where: City Hall Council Chambers (301 St. Ann's Rd.)

Why attend? To make a complaint under Section 205 of the Community Charter because:

- there is an error or omission about a name or address on the tax roll
- there is an error or omission about the inclusion of a parcel
- there is an error or omission about the taxable area or taxable frontage of a parcel
- an exemption has been improperly allowed

For a complaint to be heard by the Parcel Tax Review Panel, the complaint must be received in writing **on or before 4 p.m. May 1, 2018** to the attention of:
