- a) I am a Canadian citizen;
- b) I am 18 years of age or older today, OR if an election or assent voting is in progress, I will be 18 years of age or older on general voting day for the election or assent voting;
- c) I have been a resident of British Columbia for at least 6 months immediately before today;
- d) I have been a registered owner of real property in for at least 30 days immediately before today;
- e) I am not holding the property in trust for a corporation or any other trust;
- f) I am not entitled to register as a resident elector in _____ ;
- g) I have not registered as a non-resident property elector in relation to any other parcel of real property in _____;
- h) I have received the written consent of the majority of individuals registered as owners of the real property to be registered as the non-resident property elector for this property (if there is more than one owner of the property); and
- i) I am not disqualified under the Local Government Act or any other enactment from voting in an election or assent voting and am not otherwise disqualified by law.

The form must be completed in ink. Pencil is not acceptable.

- (1) You must meet all of the requirements in this section in order to register as a Non-Resident Property Elector.
- (2) Print applicant's surname and given names in full in block letters here.
- (3) Print the street address or legal description of the applicant's real property in relation to which the applicant is registering.
- (4) Print mailing address.
- (5) This information is required pursuant to the *Local Government Act*.
- (6) This information is to identify persons who have had a name change since the last election and who were on the list of electors.
- (7) Applicant must sign here.
- (8) A person who was present when applicant signed his/her name on line (8) must sign here.
- (9) Witness' address here. Not required if the witness is an election official.
- (10) You must attach the "Non-Resident Property Elector Consent Form" if the land title registration of the real property in relation to which a person is registering under this section indicates that there is more than one individual who is the registered owner of the real property. The person registering must do so with the written consent of the number of those individuals who, together with the person registering, are a majority of those individuals.
- (11) If person is registering at the time of voting, 2 pieces of identification (at least one with a signature) to prove identity are required.
