NOTICE is hereby given that a Parcel Tax Review Panel for Water, Sewer, Storm Water and Parks Parcel Tax Assessment purposes will be held at 9 a.m. on Wednesday, April 27, 2016 in the Council Chambers of City Hall at 301 St. Ann's Road in Campbell River, BC to hear complaints regarding the Water, Sewer, Storm Water and Parks Rolls for the year 2016.

You may make a complaint under Section 205 of the Community Charter to the Parcel Tax Review Panel for one or more of the following reasons:

- There is an error or omission about a name or address on the tax roll;
- There is an error or omission about the inclusion of a parcel;
- There is an error or omission about the taxable area or taxable frontage of a parcel;
- An exemption has been improperly allowed.

For a complaint to be heard by the Parcel Tax Review Panel, the complaint must be received in writing on or before 9 a.m., April 25, 2016 to the attention of:

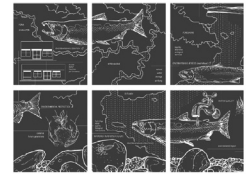

A Public Hearing will be held in the Council Chambers of City Hall located at 301 St. Ann's Road in Campbell River, B.C. at 6:30 p.m. on Monday, April 25, 2016 to provide an opportunity for public input on Bylaw No. 3623, 2016

### What is the purpose of Zoning Amendment Bylaw No. 3623, 2016?

The purpose of Zoning Amendment Bylaw No. 3623, 2016 is:

To add the following to section 3.3

"Marihuana Operation" means cultivating, growing, producing, packaging, storing, distributing, dispensing, destroying, trading or selling of cannabis (Marihuana) or its derivatives

To add the following to section 4.1

Marihuana Operations are prohibited unless expressly permitted by this bylaw

### Where can I view a copy of the bylaw?

A copy of this proposed bylaw may be inspected at the City Hall, Community Planning & Development Services Department on any regular business day between the hours of 8:30 a.m. and 4:30 p.m., Monday to Friday inclusive, from Friday, April 15, 2016 to Monday, April 25, 2016.
