# DOES YOUR ORGANIZATION CURRENTLY RECEIVE A PERMISSIVE PROPERTY TAX EXEMPTION? THEN YOU WILL NEED TO REAPPLY THIS YEAR!!!

The City's current Permissive Tax Exemption (PTE) Bylaws expire in 2016 so all PTE recipients will need to reapply to be considered for an exemption in 2017 and beyond.

PTE applications, along with all supporting documentation, will be accepted until 4:30 p.m. Friday, June 24, 2016 for 2017 exemptions.

Paper copies are available from City Hall. Submit applications to the attention of Dennis Brodie, Finance Operations Supervisor, 301 St. Ann's Road, Campbell River, BC V9W 4C7.

Permissive property tax exemptions are available for property that is either owned or held by a church, charitable, philanthropic or non-profit organization that meets the requirements prescribed by Section 224 of the Community Charter and City Council's Finance Policy.

#### 2016 PROPERTY TAX NOTICES MAILED

If you have recently purchased property or have not yet received your 2016 Property Tax Notice, please contact the City of Campbell River Finance Department at 250-286-5715 to arrange for a duplicate.

Get easy access to all your tax account information, including current balance and transactions on the City's website through **MyCity** (visit www.campbellriver.ca and click on **Accounts**).

You can pay your property taxes in person at City Hall between 8:30am – 4:30pm Monday to Friday (except for Friday, July 1 as City Hall will be closed for Canada Day). Cheques are accepted, and may be post-dated to July 4, 2016. Please note that you cannot use a credit card to pay your property taxes. If you choose to use a debit card you should also be aware that some debit cards have transaction limits that may restrict your ability to fully pay your taxes by debit card. A drop box is available at the front door for cheques or Home Owner Grant applications.

Payment of taxes can also be made at most financial institutions, as well as via online banking.

FINAL DATE FOR PAYMENT, WITHOUT BEING SUBJECT TO A 10% LATE PAYMENT PENALTY, IS JULY 4, 2016.

Payment of taxes is not a requirement to claim the Home Owner Grant.

Eligible homeowners are urged to apply for their Home Owner Grant as soon as possible either by mail, in person, or online at **www.campbellriver.ca** (click on **Home Owner Grant & Payments**). Banks and other financial institutions are **not** able to claim a grant on your behalf.

Until a Home Owner Grant is claimed, it is considered taxes outstanding and is subject to a 10% penalty if not claimed by July 4, 2016.



## RECYCLING COMING TO CONDO COMPLEXES AND APARTMENT BUILDINGS!

Campbell River City Council has adopted a Recycling and Garbage Regulation Bylaw to ensure that all multi-family buildings implement recycling services by Dec. 31, 2016.

Provincial financial incentives will enable multi-family buildings to receive recycling services from qualified collectors at a low rate and in many cases free of charge.

Earlier this year, City staff began providing multi-family building owners with information on the provincial funding and anticipated bylaw changes, as well as educational material to use with residents.

Over the next several months, City staff will continue contacting building owners to share information and offer assistance in setting recycling programs in multi-family buildings.
