A Public Hearing will be held in the Council Chambers of City Hall located at 301 St. Ann's Road in Campbell River, B.C. at 6:30 p.m. on November 7th, 2016 to provide an opportunity for public input on Bylaw No. 3640, 2016.

What is the purpose of Official Community Plan Amendment Bylaw No. 3640, 2016? To complete minor amendments to the Sustainable Official Community Plan Bylaw 3475, 2012; to align the Sustainable Official Community Plan (SOCP) and Zoning Bylaw; and to revise some policies to clarify the interpretation of the SOCP.


