

# NOTICE OF PROPOSED PERMISSIVE EXEMPTION FROM TAXATION BYLAW

Council of the City of Campbell River, under authority of the *Community Charter* will consider granting a permissive tax exemption to the following properties. Adoption of the bylaw granting this exemption will be considered at Council's virtual meeting to be held on October 19, 2020 at 3:00 p.m., via virtual video call, in the City Hall Council Chambers, 301 St. Ann's Road, Campbell River, BC.

Following is a summary of the subject property and an estimate of the amount of taxes that would be imposed on the property if they were not exempt for the year in which the proposed bylaw is to take effect and the following two years.




