## **Credit Card Recovery Fee Bylaw**

Consolidated for Convenience Purposes to include Bylaws 3781, 3816

ADOPTED June 15, 2020

### PURPOSE

A bylaw detailing when the City of Campbell River will charge a Credit Card Recovery Fee.

The Council of the City of Campbell River enacts as follows:

### **PART 1:** Title

1.1 This bylaw may be cited for all purposes as Credit Card Recovery Fee Bylaw No. 3781, 2020.

## PART 2: Credit Card Recovery Fee

#### Amd Bylaw 3816 Mar/21 service fee changed


- **2.1** The following fee is imposed for credit card or mobile device payments:
  - a) Except as set out in Section 2, when a credit card or a mobile device is used to pay for fees and charges payable to the City of Campbell River in a both card-present and a card-not-present environment, a service fee of 2.0% of the final transaction amount, net of all discounts and rebates, shall be assessed and charged to the payer in addition to the final transaction amount.
  - b) The service charge imposed under section 1 does not apply to the following exempt fees or charges:
    - (i) Recreation program registrations and services processed via the recreation system.
    - (ii) Business Licence applications and renewals.
    - (iii) Dog Licence applications and renewals.
    - (iv) Bylaw violation tickets and fines.
    - (v) Garbage tags and garbage disposal vouchers.
    - (vi) Airport Services.
  - c) The service charges assessed and charged under this bylaw are non-refundable.
