BYLAW NO. 3322

A BYLAW OF THE CITY OF CAMPBELL RIVER TO AUTHORIZE TICKETING FOR BYLAW OFFENCES.

WHEREAS Section 264 and 265 of the Community Charter, SBC Chap. 26, 2003 authorizes a Council, by bylaw to:

- a. designate a bylaw, pursuant to Section 264 (1) (a), which may be enforced by means of a form of ticket prescribed by Regulation;
- b. designate bylaw enforcement officers, prescribed by Regulation, pursuant to Section 264 (1) (b), for the purpose of enforcing bylaws;
- c. authorize the use of any word or expression on a form of ticket prescribed by Regulation, pursuant to Section 264 (1) (c), to designate an offence against a bylaw;
- d. establish penalties, prescribed by Regulation, for an offence against a designated bylaw, pursuant to Section 265 (1).

NOW THEREFORE the Council of the City of Campbell River, in open meeting assembled, enacts as follows:

- 1. This Bylaw may be cited as the "Ticketing for Bylaw Offences Bylaw No. 3322, 2007."
- 2. Those bylaws listed in Schedule 1, attached to and forming part of this Bylaw, under the title "Designated Bylaws" may be enforced by means of a ticket in the form prescribed by Regulation.
- 3. Those persons listed in Schedule 1, attached to and forming part of this Bylaw, under the heading "Designated Bylaw Enforcement Officers" are named, as prescribed by Regulation, for the purpose of enforcing corresponding Designated Bylaws.
- 4. The words or expressions set forth under the heading "Designated Offence" in Schedules 2 through 28, attached to and forming part of this Bylaw, constitute the offence, under the corresponding section, against a Designated Bylaw.
- The amounts listed in Schedules 2 through 28 under the heading "Penalty" designate the fines prescribed pursuant to Section 265 of the Community Charter for contravention of corresponding Designated Offences.
- 6. Ticket Information Bylaw No. 3018, 2004 is hereby repealed.
