

# Road Closure and Dedication Removal (Portion of Roadway Adjacent to 341 Island Highway)

Bylaw No. 3900, 2023

ADOPTED October 12, 2023

# PURPOSE

Pursuant to the provisions in the *Community Charter* in relation to establishing and closing highways, Council may, by bylaw, close a highway, or a portion of it, to traffic and remove the dedication of a highway.

The Council of the City of Campbell River enacts as follows:



- **2.1.** The Highway Dedication of the road dedicated by Plan 3686, Lot 72, Sayward District, shown as Road to be Closed on Reference Plan EPP131348 marked as Schedule "A" attached hereto and forming part of this bylaw, is removed.
- **2.2.** This Bylaw shall take effect upon the adoption thereof.
