

Road Closure and Dedication Removal (Portion of Roadway Adjacent to 2425 Island Highway South)

Bylaw No. 3918, 2023

ADOPTED October 12, 2023

PURPOSE

Pursuant to the provisions in the *Community Charter* in relation to establishing and closing highways, Council may, by bylaw, close a highway, or a portion of it, to traffic and remove the dedication of a highway.

1.

Title

1. This bylaw may be cited for all purposes as "Road Closure and Dedication Removal Bylaw No. 3918, 2023." (Portion of Roadway Adjacent to 2425 Island Highway South)

2.

Road Closure and Dedication Removal

- 2. The road dedicated by Plan 23753, District Lot 218, Comox District, shown as Road to be Closed on Reference Plan EPP129923 marked as Schedule "A" attached hereto and forming part of this bylaw, is hereby closed and stopped up to traffic of all kinds.
- **2.1.** The Highway Dedication of the road dedicated by Plan 23753, District Lot 218, Comox District, shown as Road to be Closed on Reference Plan EPP129923 marked as Schedule "A" attached hereto and forming part of this bylaw, is removed.
- 2.2. This Bylaw shall take effect upon the adoption thereof.


