DOWNTOWN TREE PRUNING

As part of the street tree maintenance program, the City will be pollarding (pruning) the London plane trees along the Shoppers Row and Pier Street sidewalks.

Work will take place Feb. 27 and Feb. 28, 8 a.m to dusk.

All branches will be cut back on the London plane trees. This controls the size of the tree and promotes sturdier branches to withstand high winds.

These trees will be in full leaf again by early summer. All other trees will be pruned using regular methods.

During this work, tree trimming equipment will temporarily take up some parking spaces.

Sidewalk areas will be closed briefly where branches are being cut.
