### TEMPORARY TRAFFIC CHANGES AND DELAYS CONTINUE INTO SEPTEMBER

South-end sewer upgrade work continues into September along Highway 19A between Maryland and Twillingate.

Mon. to Fri. between 7 a.m and 5 p.m.

The southbound lane is closed and single lane traffic is in place using Traffic Control Personnel and Temporary traffic lights in the construction zone.

Speed has reduced from 60km/h to 30km/h in the work zone. Expect delays of up to 5 to 10 minutes in either direction.



The intersections at Twillingate and 19A, and Maryland and 19A, are closed during construction hours.

Access to Twillingate via Dahl Road. Access to Maryland via Colorado Drive or Washington Drive.

Please take an alternate route if possible.

The traffic lights at Maryland Road are shut off. The public is asked to respect and follow all traffic control personnel, equipment and construction speed limits that are in place.

Members of the public are invited to apply to serve on the Board of Variance, an independent panel of five members appointed by Council to consider minor variances from the City's Zoning Bylaw. One appointment is available for a term Nov. 1, 2021 through to Mar. 31, 2024.

Appeals to the Board are generally made by homeowners or developers when compliance with a minor aspect of a Zoning Bylaw (such as a side yard setback) would cause "hardship" to the applicant.

Why join the Board? This is an opportunity to play a role in development-related decision-making in Campbell River.

No specific knowledge or qualifications are required, but an interest in civic governance and land use regulations is important.

Criteria for membership on the Board includes being available to meet during working hours, with at least 10 days' notice. Meetings generally last no longer than an hour. The Board meets when applications are received, typically 3 to 5 times a year.

During a meeting, the Board will consider whether the application is "minor" and whether "hardship" is evident, and will either deny or approve an application. The Board hears representations from an applicant and/or their neighbours before making a decision. City staff provide administrative and technical support.
