

## COUNCIL TO CONSIDER REMOVING PORTION OF LAND DEDICATED FOR ROADWAY

The City has entered into a conditional purchase contract for 325 Beech Street with Alder Heights Holding Ltd. As part of the City's review of this potential land

disposition, a portion of the laneway adjacent to this property has been deemed as surplus to the City's needs and suitable for consolidation with 325 Beech Street to better define the property lines for this parcel of land.

This would remove the roadway dedication for this portion of laneway (dedicated by Plan 10800, District Lot 69, Sayward District) and will require adoption of Road Closure and Dedication Removal Bylaw No. 3851, 2022.

# NOTICE OF TEMPORARY WATER PRESSURE DECREASE - FEB.14 TO 22

Beginning Monday, Feb. 14, City crews will be working on permanent repairs to a primary water transmission main that was damaged in April 2021. Work is expected to be completed on Tuesday, Feb. 22.

Repairs require isolating and draining the transmission main. Some areas—particularly higher-elevation areas—may notice a drop in water pressure while work is underway.

Please help to conserve water throughout the duration of this work to help lessen the strain on the water system and ensure sufficient water remains available for emergencies.



You may notice a small amount of discoloured water flowing from taps as the water system adapts to the change in flows. This is normal and expected. If this occurs, flush the COLD WATER for five minutes or until water is clear.

There is no need to report drops in pressure during this time.
