GENERAL VOTING DAY will be Sat. Oct. 15, 2022, between 8 a.m. and 8 p.m. for qualified electors of the City of Campbell River at the Campbell River Community Centre, 401-11th Avenue and Southgate Middle School, 740 Holm Road.

ADVANCE VOTING OPPORTUNITIES will be Wed. Oct. 5 and Wed. Oct. 12, 2022 between 8 a.m. and 8 p.m. at the Campbell River Community Centre, 401 - 11th Avenue.

VOTER REGISTRATION: The City uses the Provincial Voter's List from the Provincial Election. If you are not on the Voter's List, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

RESIDENT ELECTORS MUST:

- be 18 years of age or older on voting day;
- be a Canadian Citizen;
- be a resident of Campbell River on voting day;
- be a resident of BC for at least six months immediately before the day you register to vote; and
- not be disqualified by any enactment from voting in an election or be otherwise disqualified by law.

RESIDENT ELECTORS who are not on the List of Electors (Voter's List) will be required to provide two pieces of identification confirming identity and place of residence (one of which must contain your signature); or two pieces of identification confirming your identity (one of which must contain your signature) and you will be required to make a solemn declaration as to your place of residence.

Acceptable identification includes BC Drivers Licence, BC Identification Card, Social Insurance Card, Photo BC Services Card, Non-photo BC Services Card, Certificate of Indian Status as issued by the Government of Canada, Passport, BC Care Card or BC Gold Carecard, (the combined drivers licence and care card are one piece of identification), Credit Card, Debit Card, Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8, Vehicle Insurance, Birth Certificate, Citizenship Card, Statement of Employment Insurance Benefits, BC Government Cheque, Income Tax Assessment Notice, Canadian Forces Identification, Old Age Security Identification Card, Property Tax Notice or utility bill such as hydro, telephone, cable, showing residential address. Picture identification is not necessary.

NON RESIDENT ELECTORS MUST:

- be 18 years of age or older on voting day;
- be a Canadian Citizen;
- not be entitled to register as a Resident Elector of the City of Campbell River;
- have been a resident of BC for at least six months immediately preceding election day;
- have been a registered owner of real property in the City of Campbell River at least 30 days immediately preceding election day; and
- not be disqualified by any enactment from voting in an election or be otherwise disqualified by law.
- If there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non resident property elector.

NON RESIDENT PROPERTY ELECTORS who are not on the List of Electors (Voter's List) will be required to fill out an application for registration by providing proof of ownership of the property (title certificate or current title search); two pieces of identification confirming your identity (one of which must contain your signature); and a non resident property elector consent form of a majority of the registered owners, if there is more than one owner.

Non Resident Property Electors are encouraged to fill out the application and produce the required documentation at **Campbell River City Hall, 301 St. Ann's Road** prior to **4:30 p.m. on Friday, October 14, 2022** or by email to elections@campbellriver.ca
