STATUTORY NOTIFICATION

The City has received an application for Zoning Bylaw Amendment No. 3969 at 2515 Island Highway (Legal Description: LOT 23, DISTRICT LOT 67, SAYWARD DISTRICT, PLAN 6004 EXCEPT PART IN PLAN VIP67500).
