STAYING WATER WISE IN CAMPBELL RIVER

Did you know? Peak periods for water use happen in July and August - mainly due to garden and lawn irrigation.

FOLLOW THESE TIPS TO KEEP YOUR OUTDOOR GREEN AREAS **HEALTHY, WHILE CONSERVING WATER:**

- Water your lawn in the morning or evening when current restrictions allow
- ▲ Control the flow of your hose with an automatic shut-off nozzle
- Check outdoor taps and irrigation systems for leaks
- ▲ Re-use greywater from indoor showers and taps
- Use a rain barrel to collect water
