Council Remuneration Bylaw 3709, 2018

Revised: May 21, 2026

Consolidated for Convenience Purposes to include Bylaw 3709, 3788, 3888, 3939, 4018

This bylaw is a 'consolidated' version and includes amendments up to the date listed in the bylaw heading. PURPOSE

This bylaw sets out the authorization for the annual payment of remuneration and benefits for Mayor and Council.

The Council of the City of Campbell River enacts as follows:

PART 1: Title

1.1 This bylaw may be cited for all purposes as Council Remuneration Bylaw No. 3709, 2018.

Amd Bylaw 3788 Aug/20, Sections 2.1a and 2.1b, Amd Bylaw 3888 Mar/23 Section 2.1b, Amd Bylaw 3939 Dec/23 Section 2.1b, Amd Bylaw 4018, May/26

PART 2: Council Remuneration & Benefits

2.1 There shall be paid out of the annual revenue of the City of Campbell River, remuneration as follows:

- a)** Commencing on the first pay period of 2027,
 - (i)** They Mayor will be paid the sum of \$98,600 per annum;
 - (ii)** Each Councillor will be paid the sum of 35,500 per annum, or 36% of the Mayor's remuneration;
- b)** For the calendar year 2028, and for each subsequent calendar year thereafter, the annual remuneration set out in subsection a) shall be increased from the remuneration for the immediately preceding calendar year by a percentage amount equal to the percentage increase in the official Consumer Price Index (CPI) for Canada (all items) published by Statistics Canada for the period January 1 to December 31 in the immediately preceding calendar year. In the years of negative CPI, remuneration will be maintained at the previous year's level.

2.2 The Mayor and Councillors will be entitled to health care benefits (including MSP, Extended Health and Dental, AD&D and Life Insurance with a \$50,000 maximum) with 100% of the premiums paid by the City of Campbell River.

2.3 This Bylaw shall be reviewed next during the year 2022, and every four years thereafter.

PART 3: Severability

3.1 If any section, subsection, paragraph, clause, phrase or word within this bylaw is for any reason held to be invalid by the decision of a court or competent jurisdiction, such decision does not affect the validity of the remaining portions of this bylaw.

PART 4: Effective Date

4.1 This bylaw comes into force and takes effect on January 1, 2019.

PART 5: Repeal

5.1 Council Remuneration Bylaw No. 2511, 1996 as amended, is hereby repealed.

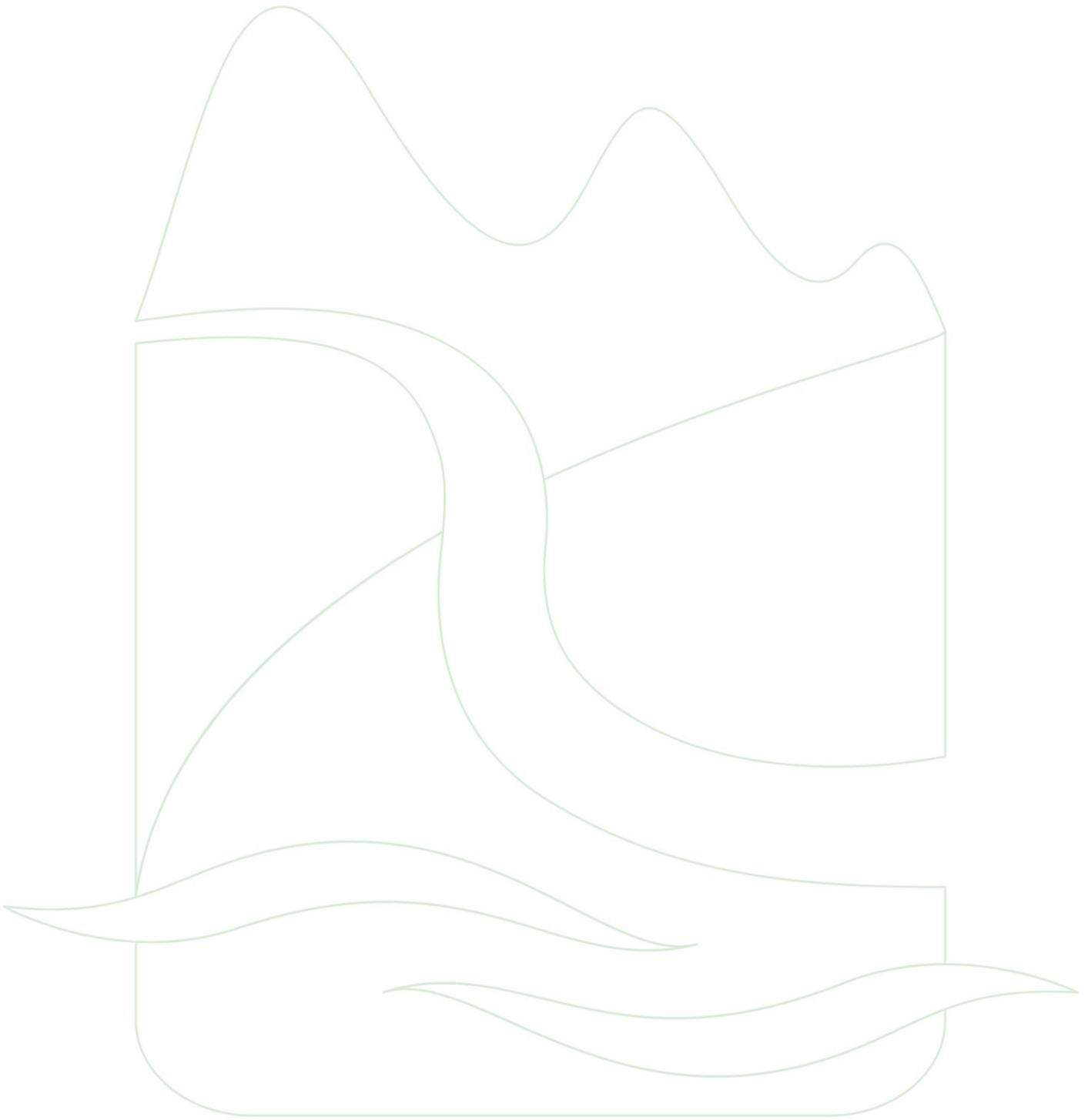
