**Road Closure and Dedication Removal  
Bylaw No. 4000, 2025  
(Portion of Pease Road)**

ADOPTED May 14, 2026

**PURPOSE**

Pursuant to the provisions in the *Community Charter* in relation to establishing and closing highways, Council may, by bylaw, close a highway, or a portion of it, to traffic and remove the dedication of a highway.

The Council of the City of Campbell River enacts as follows:

## PART 1: Title

- 1.1 This bylaw may be cited for all purposes as “**Road Closure and Dedication Removal Bylaw No. 4000, 2025 (Portion of Pease Road).**”

## PART 2: Road Closure and Dedication Removal

- 2.1 The road dedicated by Plan 15486, District Lots 1393 & 66, Sayward District, shown as Road to be Closed on Reference Plan EPP151312 marked as Schedule “A” attached hereto and forming part of this bylaw, is hereby closed and stopped up to traffic of all kinds.
- 2.2 The Highway Dedication of the road dedicated by Plan 15486, District Lots 1393 & 66, Sayward District, shown as Road to be Closed on Reference Plan EPP151312 marked as Schedule “A” attached hereto and forming part of this bylaw, is removed.
- 2.3 This Bylaw shall take effect upon the adoption thereof.

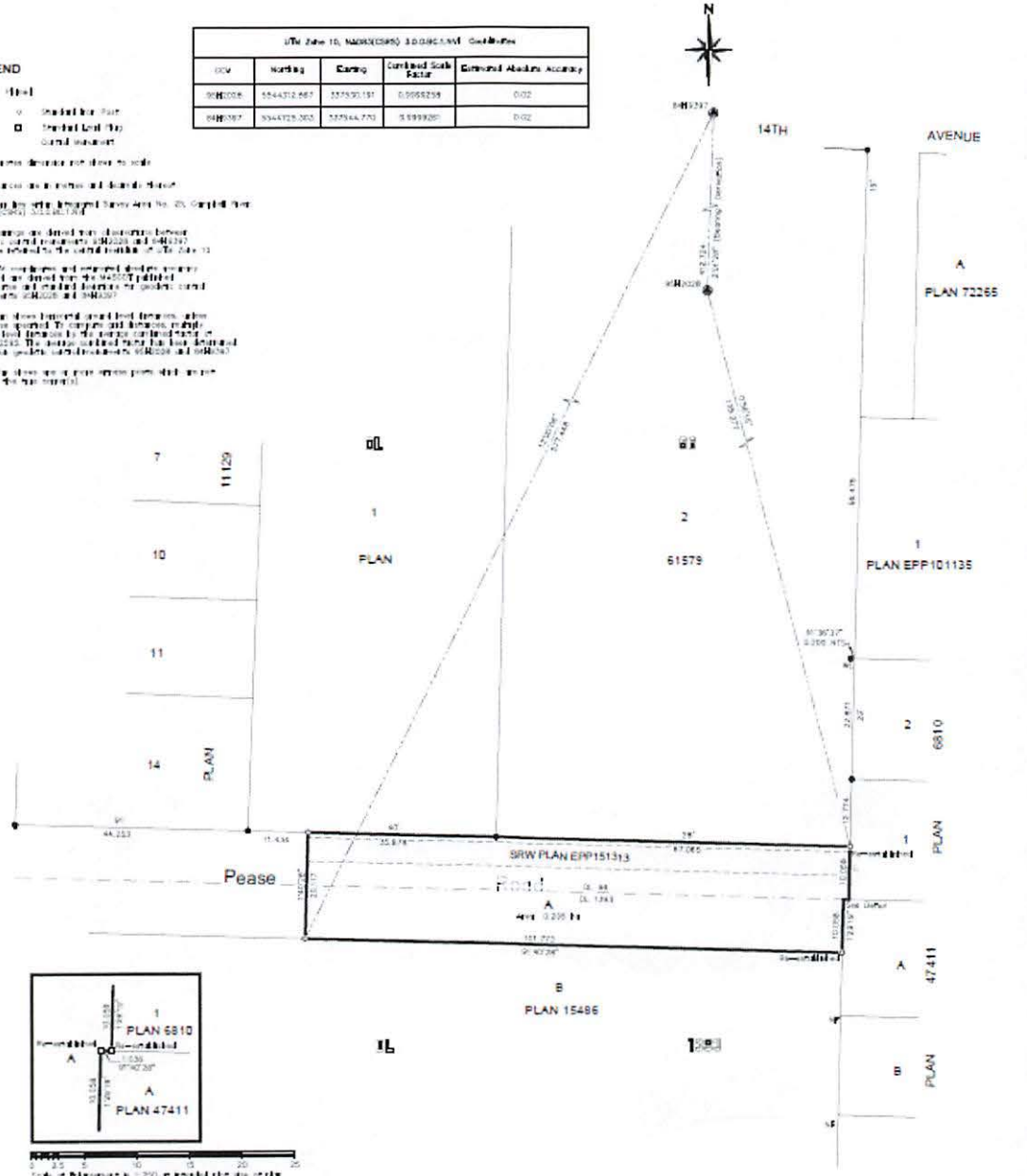
