The Council of the City of Campbell River enacts as follows:

PART 1: Title

1.1 This bylaw may be cited for all purposes as Fees and Charges Bylaw No. 4007, 2026.

PART 2: Definitions

2.1 In this bylaw unless the context otherwise requires:

- City** means the City of Campbell River.
- Recreation facility** Means:
- a) a facility or part thereof,
 - b) a park facility; or
 - c) a space or a location operated by the department responsible for recreation or the department responsible for parks or their agents.

2.2 Definitions in the following bylaws and their amendments apply to this bylaw, where applicable:

- a) Cemetery Management Bylaw, No. 3733, 2019;
- b) Clean Air Bylaw No. 3293, 2007;
- c) False Alarm Fees Bylaw No. 3498, 2013;
- d) Fireworks Regulation Bylaw No. 3297, 2007;
- e) Fire Services Bylaw No. 2612 1997;
- f) Sanitary Sewer Connections Bylaw No. 1507, 1985;
- g) Water Regulations Bylaw, No. 3216, 2006;
- h) Zoning Bylaw No. 3250, 2006.

PART 3: Reducing Fees or Charges

3.1 The following staff members in Column A may reduce a fee set out in a schedule listed in Column B by up to 100% at their discretion, subject to the reasons set out in Section 3.3 and the limitations within Section 4.1:

Column A -Staff Member	Column B - Schedule
City Manager	All schedules
Director of Operations	Schedules A, H, J and K-1 to K-11
Director of Community Safety	Schedules B, C, D, E, or I
Director of Community Planning & Livability	Schedules F, K-1 to K-11

- 3.2** Any reduced fees must be reported to City Council in a timely manner outlining the amount of the fees reduced and the justification for reducing the fee.
- 3.3** The staff member set out in Column A of Section 3.1 may reduce a fee for a person by up to 100% based on the following reasons:
- a) The person operates as a not-for-profit organization or a charitable organization;
 - b) The person is part of a recreation group that the City wishes to support;
 - c) The person is hosting an event to raise money for a charitable organization;
 - d) The person is hosting an event on behalf of the City;
 - e) The person is doing something or giving something for the benefit of the City in exchange for the reduction or waiver of the fee or;
 - f) The person has a partnering agreement with the City.
- 3.4** Any fees reduced by staff shall be granted on a one-off or non-continuous basis in order to avoid organizational reliance on reducing of fees for the continuation of programs or services.
- 3.5** Organizations that receive a Grant from the City are not eligible for any fee reduction under this Bylaw without the prior authorization of Council.

PART 4: Exceptions

- 4.1** As an exception to PART 3, the staff member set out in Section 3.1, Column A will not reduce a fee for the following reasons:
- a) The person is a business which is operating for profit;
 - b) The person is a business which does not have a partnering agreement with the City; or
 - c) The amount of the fees owing is based on the costs to provide the services and expenses incurred by the City.

PART 5: Administrative Fees

- 5.1** If a schedule refers to an administrative fee, then a person shall pay an administrative fee of 15% of the costs for any fee to which an administrative fee is applied.

PART 6: Refunding Fees

- 6.1** Except where the fee is identified as non-refundable, the City may issue a refund of:
- a) 100% if the person who has paid the permit fee applies for the refund in writing before the City has issued the permit less refund process fee; or
 - b) 50% if the person who has paid the permit fee applies for the refund in writing after the City has issued the permit.

6.2 Section 6.1 shall not apply to any deposit that a person has paid pursuant to this bylaw.

PART 7: Taxes

7.1 All fees are exclusive of applicable taxes unless otherwise specifically stated within this bylaw.

PART 8: Amendments

 - (e) Downtime means from 8:30 a.m. to 12 Midnight;
 - (f) Family means a maximum of 2 Adults and a maximum of 2 Youths;
 - (g) Pre-school means a person who is less than 6 years old;
 - (h) Non-designated area means the area in which activities are taking place within no specified location that does not interfere with any activities taking place in a Designated Area.
 - (i) Senior means a person who is 60 years older or older;
 - (j) Teen means a person who is between 13 years old and 18 years old;
 - (k) Youth means a person who is 18 years old or younger;
3. In order to qualify to as a Family to use the Family Rate, at least one Adult must accompany the Youths to the family sessions.

Liability Insurance:

4. A person shall obtain liability insurance if the person is
 - (a) a Commercial Renter; or
 - (b) holding an event at Recreation Facility which:
 - i. Serves alcohol;
 - ii. Has 150 or more attendees or participants; and
 - iii. Activity occurring at the event is considered high risk in nature.
5. A person who must obtain liability Insurance shall adhere to the following:
 - (a) ensure that the liability insurance meets the following requirements:
 - i. names the City as an additional insured ; and
